- a. These rules govern the KNCI Educator Spotlight 8.31-10.29 ("Contest"), which is being conducted by KNCI ("Station"). The Contest begins on Monday, August 31, 2020 and ends on Wednesday, October 28, 2020 ("Contest Dates"). Entrants may enter via online only.
- b. To nominate yourself, or an Educator you know for entry in the Contest, entrant may enter online beginning on Monday, August 31, 2020 at 12AM PST ZONE and ending on Wednesday, October 28, 2020 at 12AM PST ("Entry Period") as follows:
 - i. Each entry consists of an entry form and the submission of a single photograph ("Submission"). To enter online, visit KNCIFM.com and follow the links and instructions to enter the Contest and complete and submit the Submission during the Entry Period outlined above. Submissions are subject to all notices posted online including but not limited to the Station's Terms of Use and Privacy Policy. Only one (1) Submission per eligible Entrant during the Entry Period regardless if Entrant has more than one email address. Multiple Entrants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Submissions submitted may not be acknowledged or returned. Proof of entry of a Submission shall not be deemed proof of receipt by the Contest Administrator.
- c. The below criteria is required when including a photo with your nomination.
 - i. Photographs must be of persons eighteen (18) years or older featuring their first day back to school, the office, a restaurant, or a first car, first

home, first pet, etc. Any photographs that include children must have a photo release signed by a parent or legal guardian. Any photographs that include sculptures, statues, architecture, paintings, and other works of art will not be accepted. When photographing the work of others, it must be as an object in its environment and not a full-frame close-up of another person's art.

- ii. The photograph, in its entirety, must be a single work of original material taken by the person entering the Submission. By entering the Contest, the Entrant represents, acknowledges, and warrants that the submitted photograph is an original work created solely by the Entrant, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph. By entering the Contest, the Entrant acknowledges, and warrants that the submitted photograph may be used by the Contest sponsor may use submitted photos on their owned-and-operated website/social media channels.
 - iii. Photographs must contain only a picture of the Educator. Each photograph, in its entirety, must be a single work of original material taken of the Educator by permission of the Educator. By entering the Contest, the Educator represents, acknowledges, and warrants that the submitted photograph is an original work created solely by the Educator, that the photograph does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity, and that no other party has any right, title, claim, or interest in the photograph.
 - iv. The nominee must be fully dressed in the photograph and the photograph must not contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.
 - v. The photograph must not contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content.
- d. Nominators must answer the following ten (10) questions about the nominee for the nominee to be considered in the Contest.
- 1. Your email
 - 2. Are you nominating yourself, or someone else?
 - 3. First & last name of nominee?
 - 4. Nominee's contact number? (including area code)
 - 5. Nominee's email address?

6. Where does your nominee work?
 7. What is their job title?
 8. Why should Pat, Tom, & Cody choose this person to be in the educator spotlight?
 9. Your first & last name?
 10. Your contact number? (including area code)
- e. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
 - f. Each Nominator may submit only one (1) Submission per nominee. When an eligible Submission can be determined, there will be approximately one (1) weekly winner selected in the Contest.
 - g. The Contest Sponsor and/or Station may discard any Submission that it deems suspicious, objectionable or in poor taste, as determined by the Contest Sponsor and Station in their sole discretion.
 - h. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
 - i. Only one (1) entry per person is permitted regardless of the method of entry. There will be up to a total of NINE (9) winner(s) selected in the Contest.
 - j. All online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all educators who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in the Sacramento Metropolitan area as defined by Nielsen; this includes Yolo, Sacramento, Sutter, Nevada, Placer, and El Dorado Counties. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor,

of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.

- c.
