1. HOW TO ENTER

- a. These rules govern the St. Jude Radiothon 12.14 & 12.15 ("Contest"), which is being conducted by KNCI ("Station"). The Contest will award a total of twenty-eight (28) different prizes separate drawings conducted hourly between 5:00 a.m. PST and 7:30 p.m. PST on Thursday, December 14, 2023, and between 5:00 a.m. PST and 6:00 p.m. PST Friday, December 15, 2023 ("Contest Dates"). Each drawing will feature a different incentive prize per hour and will draw from only those entries submitted during the hourly drawing period. Entrants may enter via texting ("on-air") or online only.
- b. To enter the Contest, entrant may enter by text message or online beginning on Thursday, December 14, 2023, at 5AM PST-6:30AM PST, 6AM PST- 7:30AM, 7AM PST-8:30AM PST, 8AM PST-9:30AM, 9AM PST-10:30AM, 10AM PST-11:30AM, 11AM PST-12:30PM, 12PM PST- 1:30PM PST, 1PM PST-2:30PST, 2PM PST-3:30PM PST, 3PM PST-4:30PM, 4PM PST-5:30PM PST, 5PM PST-6:30PM PST, and 6PM PST-7:30PM PST. ("Entry Period"). To enter via text message, listen to the Station each weekday beginning on Thursday, December 14, 2023, at 5AM PST-6AM PST, 6AM PST-7AM PST, 7AM PST-8AM PST, 8AM PST-9AM PST, 9AM PST-10AM PST, 10AM PST-11AM PST, 12PM PST-1PM PST, 1PM PST-2PM PST, 2PM PST-3PM PST, 3PM PST-4PM PST, 4PM PST-5PM PST, 5PM PST-6PM PST, and 6PM PST-7PM PST and ending on Friday, December 15, 2023, at 5AM PST-6AM PST, 6AM PST-7AM PST, 7AM PST-8AM PST, 8AM PST-9AM PST, 9AM PST-10AM PST, 10AM PST-11AM PST, 12PM PST-1PM PST, 1PM PST-2PM PST, 2PM PST-3PM PST, 3PM PST-4PM PST, 4PM PST-5PM PST, and 5PM PST-6PM PST, during these dates for the on-air personality to announce the cue to text. Upon hearing the cue to text, listeners must text the Keyword announced on-air to 1-916-766-5105 within the time period specified to enter the Contest. Only one entry per Keyword per person is permitted. Entrants may submit a new entry for each Keyword, provided that an

entrant may not win more than one prize during the Contest. By texting to enter the Contest, the listener consents to receive automated messages about the Contest on his or her cell phone. Standard message and data rates may apply. The frequency of automated message(s) that an individual may receive after entering the Contest may vary. If an individual wishes to stop receiving text messages, he or she can text STOP to cancel such messages.

- c. Terms are available at the Station's Terms of Use. Station assumes no responsibility for charges incurred for text messaging, including, without limitation, any text messages or Contest notices from the Station. To be eligible to win, entrants in the Contest must provide all information requested including entrant's full name, complete address (including zip code), email address, day and evening phone numbers, and date of birth to verify eligibility. P.O. Boxes are not permitted as addresses.
- d. To enter the Contest online, visit KNCIFM.com and follow the links and instructions, include the short code 1-916-766-5105, the Keyword announced on-air on the Station, and complete and submit the online entry form during the Entry Period outlined above. Online entrants are subject to all notices posted online including but not limited to the Station's Privacy Policy. Only one (1) entry per Keyword per person is permitted. Multiple participants are not permitted to share the same email address. P.O. Boxes are not permitted as addresses. Entries submitted may not be acknowledged or returned. Proof of submission of an entry shall not be deemed proof of receipt by the Contest Administrator. Online entrants will also be required to listen to the Station during the times listed above for the Keyword and short code and must submit them in the online entry form.
- e. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- f. Entrants may be provided with an opportunity to opt-in for membership/participation as part of the entry process, but membership/participation is not required to enter the contest.
- g. Only one (1) entry per person is permitted regardless of the method of entry. There will be up to a total of twenty-eight (28) winner(s) selected in the Contest, with one (1) winner per drawing.
- h. All text message and online entries must be received by the end of the Entry Period.

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations, including winning a prize for a previous Keyword in this Contest, are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to entering the current contest are not eligible to participate. Persons who have won a prize valued between \$101 and \$499 in the ninety (90) days prior to entering the current contest are not eligible to participate. Persons who have won a prize valued between \$500 and \$999 in the six (6) months prior to entering the current contest are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to entering the current contest are not eligible to participate. These restrictions also apply to immediate household members of contest or prize winners.

- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. PRIZES

- a. Twenty-eight (28) prizes will be awarded. Each hour of the St. Jude Radiothon holds a different incentive prize per hour. The prize list is attached on page 12

with the approximate retail value ("ARV") of each prize listed. Any difference between stated ARV and actual value will not be awarded. Transportation costs are excluded in the given price. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). The prize is valid only on the date(s) printed on the prize, and they are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or credit at any time, nor will they be replaced if lost or stolen. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station or Contest Administrator or Sponsor, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). The Station, in its sole discretion, reserves the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize related event(s).

The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security, or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- c. This Contest is NOT SPONSORED BY OR ASSOCIATED WITH ANY OF THE VENUES, EVENTS, or ARTISTS RELATED TO THE PRIZES.
- d. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.
- e. All prizes are awarded "as is" and the station does not make (and is not responsible for) any representations, guarantees, or warranties of any kind, express or implied, in fact or in law, relating to any prize (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose), and all such warranties are hereby disclaimed.

4. WINNER SELECTION AND NOTIFICATION

- a. Decisions of the Station management with respect to the Contest are final.
- b. Twenty-eight (28) prize winner(s) will be selected in the Contest during the following periods of time ("Drawing Periods")
 - All twenty-eight (28) prize winners will be selected on Monday, December 18, 2023, at approximately 10:00 AM PST in a random drawing of all eligible text and online entries received between 5:00 AM PST – 6:00 PM PST on Thursday, December 14, 2023 and 5:00 AM PST – 5:00 PM PST on Friday, December 15, 2023.
- c. Odds of winning depend upon the number of eligible text message or online entries received with the correct Keyword during the applicable Drawing Period.
- d. Entries are specific to each designated Drawing Period and will not be included in subsequent drawings.
- e. Winners must listen to the Station to win but do not need to be present to win. If public health conditions do not permit a Winner to claim the prize in person within thirty (30) days, the Station will coordinate with the Winner to confirm Winner's identity remotely and to deliver the prize by mail or other means of delivery. If a Winner has a prize shipped, the Winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping. - a. Any attempt by any entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and logins or any other methods may void that entrant's entries and that entrant may be disqualified. The use of any device to automate multiple entries is prohibited. Any use of robotic, repetitive, automatic, programmed or similar entry methods or agents (including, but not limited to, promotion entry services or proxies) will void all entries by that entrant at the Station's discretion. The Station's or its Contest Administrator's computer or telephone system is the official time keeping device for this Contest. In the event of a dispute, online entries will be deemed to have been submitted by the Authorized Account Holder. The "Authorized Account Holder" is the natural person who (i) is assigned to an email address by an internet access provider, online service provider, or other organization that is responsible for assigning email addresses for the domain associated with the submitted email address, or (ii) is assigned to the mobile telephone number by a telecommunications provider, or other organization that is responsible for assigning such numbers. The Station, in its sole discretion, reserves the right to disqualify any person who it believes is tampering with the entry process or the operation of the Contest. Failure to comply with the rules of the Contest may result in an entrant's disqualification and/or forfeiture of any prize or prizes.
