1. HOW TO ENTER

- a. These rules govern the MS: CARRIE UNDERWOOD VINYL + GP 1.29 ("Contest"), which is being conducted by KNCI ("Station"). The Contest begins on Monday, January 29, 2024, and ends on Friday, February 2, 2024 ("Contest Dates"). Entrants may enter on-air only.
- b. To enter the Contest, entrant may enter on-air beginning on Monday, January 29, 2024, at 6AM PST-7AM PST and ending on Friday, February 2, 2024, at 6AM PST-7AM PST ("Entry Period").
 - i. To enter on-air, listen to the Station each weekday beginning on Monday, January 29, 2024, at 6AM PST-7AM PST and ending on Friday, February 2, 2024, at 6AM PST-7AM PST during the Entry Period for the air personality to announce the cue to call.
 - ii. Upon hearing the cue to call, the on-air talent will solicit listeners to call contest line: (916) 766-5105 after Pat, Tom, and/or Cody ask the trivia question of the day. Once the cue to call airs, the first caller must guess the correct answer to the question. If the entrant does not correctly answer, he/she will be disqualified, and the station will take the 2nd caller and the process will be repeated. If guessed correctly, entrant will win a prize upon confirmation of eligibility. At the time of entrant's call, entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers, email address, and date of birth in order to be eligible to win. P.O. Boxes are not permitted as addresses. In the event that the selected caller is disconnected or is found to be ineligible, that caller will not win a prize and the next eligible caller who successfully

makes it through on the call-in line and completes the call will be a winner. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant.

- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. Only one (1) entry per person is permitted, regardless of the method of entry. There will be up to a total of five (5) winner(s) selected in the Contest.
- e. All entries must be received by the end of the Entry Period

2. ELIGIBILITY RESTRICTIONS

- a. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in the Sacramento Metropolitan area as defined by Nielsen; this includes Yolo, Sacramento, Sutter, Nevada, Placer, and El Dorado Counties. Void where prohibited or restricted by law.
- b. The following individuals are NOT eligible to enter Station contests at any time, even if such individuals meet the age and residency requirements above: (1) Any employees (i.e., full-time, part-time and/or temporary employees) of the Station, Bonneville International Corporation, other area radio stations, Contest Sponsor, of any advertising and promotion agencies, and/or of the respective parent entities, subsidiaries, affiliated companies of each; (2) Any immediate family members of such employees, including without limitation current and/or ex-spouses, parents, grandparents, children, grandchildren, siblings, in-laws, and/or steps in any of the foregoing categories; and (3) Any other individual legally residing in the same household (i.e., at the same address) of such employees, including without limitation roommates, housemates, significant others, and partners.
- c. Unless the Station otherwise specifies, persons who have previously won a prize (cash, services, merchandise) from a contest or Station event from any of the Bonneville International Radio Stations are subject to the following restrictions: Persons who have won a prize valued up to \$100 in the thirty (30) days prior to entering the current contest are not eligible to participate. valued between \$500 and \$999 in the six (6) months prior to entering the current contest are not eligible to participate. Persons who have won a prize valued at \$1,000 or more in the twelve (12) months prior to entering the current contest are not eligible to participate. These restrictions also apply to immediate household members of contest or prize winners.

- d. To claim a prize, the winner(s) must provide valid government-issued photo identification and provide their complete address, date of birth and phone number, and Social Security Number.
- e. Entrants are required to provide truthful information and the Station will reject and delete any entry that it discovers to be false or fraudulent. The Station will disqualify any entrant who does not meet the eligibility requirements and will also delete any entry as required by law.
- f. This Contest is subject to all applicable federal, state and local laws and regulations. By participating, entrant agrees to comply with these Official Rules and the decisions of the Station, which are final and binding in all respects.

3. PRIZES

- a. Five (5) qualifying prize(s) will be awarded. Each qualifying prize consists of one (1) vinyl record of Carrie Underwood's *Denim & Rhinestones Deluxe Edition*. The Approximate Retail Value ("ARV") of the prize(s) is \$50. Transportation costs are [excluded] in the given price. The winner(s) will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s). Tickets are valid only on the date(s) printed on the tickets, and they are not refundable or transferable, may not be sold to a third party, and may not be substituted or exchanged for cash or credit at any time, nor will they be replaced if lost or stolen. If a prize-related event is unable to take place as scheduled, for reasons such as cancellation, preemption, postponement or unavailability, including for weather, or for any reason beyond the control of the Station or Contest Administrator or Sponsor, their sole responsibility to the winner(s) will be to award the remaining available elements of the prize(s) and no substitution or compensation will be provided for the unawarded elements of the prize(s). The Station, in its sole discretion, reserves the right to deny entry to or to remove the winner(s) and/or guest(s) if either engages in disruptive behavior or in a manner with intent to annoy, abuse, threaten or harass any other person at the prize related event(s).
- b. One (1) grand prize(s) will be awarded in the Contest. The grand prize consists of the following: one (1) ticket for winner and one (1) ticket for their guest to see Carrie Underwood at her Las Vegas Residency on their choice of date, two (2) night stay at Resorts World Las Vegas Hotel, and a \$500 airfare travel allowance in the form of an American Express gift card. The ARV of the grand prize is \$1,450. Ground transportation costs are [excluded] in the given price. Any difference between stated value and actual value will not be awarded. Certain

restrictions may apply and is subject to hotel availability. Advanced reservations are required. Any difference between stated value and actual value will not be awarded. Prize(s) is subject to availability. The Station assumes no responsibility or liability for damages, loss, or injury resulting from acceptance or use of the prize. The Station is not responsible for replacing tickets in the event of show cancellations as a result of weather, promoter, or performer actions. The Station reserves the right, in its sole discretion, to cancel or suspend the Contest should a virus, bug, computer, or other problem beyond the control of the Station corrupt the administration, security or proper execution of the Contest, or the Internet portion of the Contest. Decisions of the Station are final.
- d. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded.
- e. All prizes are awarded "as is" and the station does not make (and is not responsible for) any representations, guarantees, or warranties of any kind, express or implied, in fact or in law, relating to any prize (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose), and all such warranties are hereby disclaimed.

4. WINNER SELECTION AND NOTIFICATION

- b. Five (5) qualifying prize winner(s) and one (1) grand prize winner(s) will be selected on-air as described above in Section 1 of these Official Rules.
- c. Odds of winning a qualifying prize depend upon the number and order of eligible phone calls received. Odds of a qualifying prize winner winning the grand prize are one (1) in five (5).
- d. Winners must listen to the Station to win but do not need to be present to win.
