- a. These rules govern the KNCI **TICKET TALKBACK** ("Contest"), which is being conducted by KNCI-FM ("Station"). The Contest begins on Thursday, September 19, 2024, and ends on Thursday, September 26, 2024 ("Contest Dates"). Entrants may enter in the KNCI app only. KNCI-FM may elect at its sole discretion, to continue the contest beyond this date if it so chooses.
- b. To enter the Contest, entrant may enter in the KNCI app beginning on Thursday, September 19, 2024, at 12AM (PT) "Pacific Time" and ending on Thursday, September 26, 2024, at 11:59PM (PT) ("Entry Period").
  - i. To enter in the KNCI app, download the KNCI App, click on the Call In button, tell us your name, where you're from, and who your looking forward to seeing the most at CITP 2 this year beginning on Thursday, September 19, 2024, at 12AM (PT) and ending on Thursday, September 26, 2024, at 11:59PM (PT). Entrant will be required to provide all information requested including entrant's full name, complete address (including zip code), day and evening phone numbers and date of birth to be eligible to win. P.O. Boxes are not permitted as addresses. There is no limit to the number of times a listener may attempt to call in to win, but a listener may be a winner only once during the Contest. Multiple participants are not permitted to share the same phone number, and only one phone number may be used per entrant. One (1) winner will be selected from the entries made through the KNCI app.
- c. Due to delays in the online streaming of the Station's broadcast signal, listeners to the online stream may not be able to participate in, or may be disadvantaged in participating in, the Contest. Entrants should not rely on streamed broadcasts and are encouraged to listen to the Station on-air versus online. The Station is not responsible for any disadvantages or losses that result from online streaming

- delays of any nature, nor is station otherwise responsible for any delays in online streaming.
- d. There will be one (1) prize(s) that will be awarded in the Contest. All entries must be received by the end of the Entry Period.

### e. ELIGIBILITY RESTRICTIONS

- c. The Contest is open to all persons who are legal U.S. residents of the state of California, eighteen (18) years of age or older, and who reside in the Sacramento Metropolitan area as defined by Nielsen; this includes Yolo, Sacramento, Sutter, Nevada, Placer, and El Dorado Counties. Void where prohibited or restricted by law.
- d. The Approximate Retail Value ("ARV") of the prize(s) is \$312. Transportation costs are excluded in the given price. Prize will be issued electronically. The winner will be solely responsible for all taxes and all other fees and expenses not specified herein associated with the receipt and use of the prize(s).
- b. One (1) prize(s) will be awarded in the Contest. All sales, prizes and other taxes, gratuities and any other incidentals associated with the prizes are the sole responsibility of the prizewinner(s). Prizes are not transferable or exchangeable and may not be substituted, except by sponsors for reasons of unavailability, in which case, a prize of equal or greater value will be awarded. Decisions of the Station are final.
- c. If due to a printing, production or other error, more prizes are claimed than are intended to be awarded for any prize level, the intended prizes will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. #### 3. WINNER SELECTION AND NOTIFICATION

Sacramento. If a winner chooses to have a prize shipped, the winner will be required to sign a release that the Station and any Released Parties (defined below) are not responsible if the prize is late, lost, stolen, misdirected, undeliverable, or damaged during shipping.
